

Specific Provisions of the FTR Affected by this Lump Sum Program

In Chapter 302 of Title 41 of the CFR (Relocation Allowances), impacts are as follows:

Section	Impact
Part 302-1 General Rules	Lump sum applies to transfers within CONUS only.
Part 302-2 Employee Eligibility Requirements	Lump sum applies to transfers within CONUS only. Accordingly, 302-2.2(b), 302-2.3(b)–(e), 302-2.5, 302-2.102, and 302-2.103 do not apply.
Part 302-3 Subpart A – New Appointee	New appointees are not eligible for the relocation expenses test program.
Part 302-3 Subpart B – Transferred Employees and Other Relocated Employees	302-3.100 - Paragraph (a) is superseded by lump sum. The remaining paragraphs do not apply.
Part 302-3 Subpart C – Types of Transfers	302-3.200 - (Relocation of Two or More Employed Immediate Family Members) is replaced by the lump-sum schedule. 302-3.203–211 do not apply to the program.
Part 302-3 Subpart D – Relocation Separation	Does not apply to the relocation expenses test program.
Part 302-3 Subpart E – Employee's Temporary Change of Station	Does not apply to the relocation expenses test program.
Part 302-3 Subpart F – Agency Responsibilities	302-3.500 is superseded by the relocation expenses test program, as applicable. 302-3.501–302-3.503 - Do not apply to the relocation expenses test program.
Part 302-4 Allowances for Subsistence and Transportation	Allowances under this part that apply to CONUS-to-CONUS transfers are superseded by the relocation expenses test program lump-sum payment. Regulations in this part that apply to other than CONUS-to-CONUS transfers do not apply.
Part 302-5 Allowance for House hunting Trip Expenses	Does not apply to the relocation expenses test program.
Part 302-6 Allowance for Temporary Quarters Subsistence Expenses	Allowances under this part that apply to CONUS-to-CONUS transfers are superseded by the relocation expenses test program lump-sum payment.

Specific Provisions of the FTR Affected by this Lump Sum Program

Part 302-7 Transportation and Temporary Storage of Household Goods, Professional Books, Papers, and Equipment (PBP&E), and Baggage Allowance	Allowances under this part that apply to CONUS-to-CONUS transfers are superseded by the relocation expenses test program lump-sum payment.
Part 302-8 Allowances for Extended Storage of HHG	Does not apply to the relocation expenses test program.
Part 302-9 Allowances for Transportation and Emergency or Temporary Storage of a Privately Owned Vehicle	Does not apply to the relocation expenses test program.
Part 302-10 Allowances for Transportation of Mobile Homes and Boats Used as a Primary Residence	Allowances under this part that apply to CONUS-to-CONUS transfers are superseded by the relocation expenses test program lump-sum payment.
Part 302-11 Allowances for Expenses Incurred in Connection with Residence Transactions	Allowances under this part that apply to CONUS-to-CONUS transfers are superseded by the relocation expenses test program lump-sum payment.
Part 302-12 Use of a Relocation Services Company	Does not apply to the relocation expenses test program.
Part 302-14 Home Marketing Incentive Payments	Does not apply to the relocation expenses test program.
Part 302-15 Allowance for Property Management Services	Does not apply to the relocation expenses test program.
Part 302-16 Allowance for Miscellaneous Expenses	Allowances under this part that apply to CONUS-to-CONUS transfers are superseded by the relocation expenses test program lump-sum payment.
Part 302-17 Taxes on Relocation Expenses	Allowances under this part that apply to CONUS-to-CONUS transfers are superseded by the relocation expenses test program lump-sum payment.
